LOV for Food and Accommodation for the conduct of Various AMAD-APS Activities for FY 2025 in Roxas City.

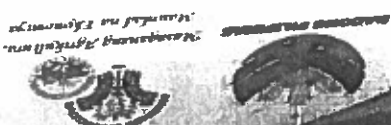
WHEREAS, the Department of Agriculture has a Purchase Request for the LOV for Food and Accommodation for the conduct of Various AMAD-APS Activities for FY 2025 in Roxas City with an Approved Budget for the Contract (ABC) of Two Hundred Thirty-Four Thousand Four Hundred Fifty Pesos Only (Php 234,450.00).

WHEREAS, on January 22, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) NESTAS HILLTOP HOTEL & RESTAURANT; (2) HOTEL VERONICA; (3) MVW RESTAURANT & TOURIST INN

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm, on January 29, 2025, NESTAS HILLTOP HOTEL & RESTAURANT, HOTEL VERONICA and MVW RESTAURANT & TOURIST INN submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, NESTAS HILLTOP HOTEL & RESTAURANT is considered as the lowest offeror and with price quotation within the ABC but due to non-compliance of submission of its 2025 Mayor's Permit and PhilGEPS, HOTEL VERONICA is considered as the second lowest offeror with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the LOV for Food and Accommodation for the conduct of Various AMAD-APS Activities for FY 2025 in Roxas City to HOTEL VERONICA in the amount of Two Hundred Twenty-Five Thousand Four Hundred Fifty Pesos Only (Php 225,450.00).
