**Lease of Venue for the Conduct of Various Corn Program Meetings, Assessments, and Workshops-Lot 4**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Lease of Venue for the Conduct of Various Corn Program Meetings, Assessments, and Workshops-Lot 4 with an Approved Budget for the Contract (ABC) of One Hundred Sixty-Two Thousand Three Hundred Fifty Pesos Only (Php 162,350.00);

**WHEREAS**, on February 19, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ALOBIJOD COVE RESORT; (2) VILLA IGANG BEACH RESORT; (3) RAYMEN BEACH RESORT CORP.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 pm. on February 26, 2025, ALOBIJOD COVE RESORT, VILLA IGANG BEACH RESORT and RAYMEN BEACH RESORT CORP. submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ALOBIJOD COVE RESORT is considered as the lowest offer and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
