Lease of Venue for the Conduct of Various Corn Program Meetings, Assessments, and Workshops-Lot 6

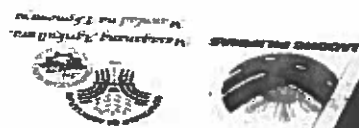
WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue for the Conduct of Various Corn Program Meetings, Assessments, and Workshops-Lot 6 with an Approved Budget for the Contract (ABC) of Eighty-Nine Thousand Two Hundred Fifty Pesos Only (Php 89,250.00).

WHEREAS, on February 19, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) NATURE'S VILLAGE RESORT; (2) ACACIA HOTEL BACOLOD; (3) L'FISHER HOTEL

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on February 26, 2025, NATURE'S VILLAGE RESORT, ACACIA HOTEL BACOLOD and L'FISHER HOTEL submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, NATURE'S VILLAGE RESORT is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lease of Venue for the Conduct of Various Corn Program Meetings, Assessments, and Workshops-Lot 6 to NATURE'S VILLAGE RESORT in the amount of Eighty-Nine Thousand Two Hundred Fifty Pesos Only (Php 89,250.00).
