Procurement of Food and Accommodation with Lease of Venue for the Conduct of Local Farmer Technicians Quarterly Meeting and Workshop- Lot 5

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Food and Accommodation with Lease of Venue for the Conduct of Local Farmer Technicians Quarterly Meeting and Workshop- Lot 5 with an Approved Budget for the Contract (ABC) of One Million Eight Hundred Six Thousand Pesos Only (Php 1,806,000.00).

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, PUNTA VILLA RESORT INC. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
