Procurement of Food and Accommodation with Lease of Venue for the Conduct of Local Farmer Technicians Quarterly Meeting and Workshop- Lot 6

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Food and Accommodation with Lease of Venue for the Conduct of Local Farmer Technicians Quarterly Meeting and Workshop- Lot 6 with an Approved Budget for the Contract (ABC) of One Million Eight Hundred Three Thousand Six Hundred Pesos Only (Php 1,803,600.00).

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on February 28, 2025, NATURE'S VILLAGE RESORT, BACOLOD REAL ESTATE DEVT CORP., MAYS ORGANIC GARDEN RESTAURANT and O HOTEL/ MULTI-LUCK CORP. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, NATURE'S VILLAGE RESORT is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
