Procurement of Supply and Delivery of Catering Services for the conduct of Stakeholders Meeting in 21 AMIA Villages (by LOT)

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Catering Services for the conduct of Stakeholders Meeting in 21 AMIA Villages (by LOT) with an Approved Budget for the Contract (ABC) of Forty-Eight Thousand Six Hundred Pesos Only (Php 48,600.00) for lot 1 and Thirty-Five Thousand One Hundred Pesos Only (Php 35,100.00) for lot 3 and Fifty-Eight Thousand Five Hundred Pesos Only (Php 58,500.00) for lot 6.

WHEREAS, on Feb. 7, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) LUCILLA'S CATERING SERVICES, OPC; (2) MAMBA BAR AND RESTAURANT; (3) ESCA'S GARDEN RESTAURANT; (4) ZAMEO MULTI-PURPOSE COOPERATIVE for lot 1 and (1) LUCILLA'S CATERING SERVICES, OPC; (2) JI SEAFOODS & RESTAURANT; (3) PARVANA INN & SUITES; (4) EDEN RESORT HOTEL for lot 3 and (1) LUCILLA'S CATERING SERVICES, OPC; (2) MAY'S ORGANIC GARDEN RESTAURANT; (3) A&N EATERY; (4) ROGER'S CUISINE for lot 6.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 14, 2025, LUCILLA'S CATERING SERVICES, OPC, MAMBA BAR AND RESTAURANT, ESCA'S GARDEN RESTAURANT and ZAMEO MULTI-PURPOSE COOPERATIVE submitted their quotations for lot 1 and LUCILLA'S CATERING SERVICES, OPC, JI SEAFOODS & RESTAURANT, PARVANA INN & SUITES and EDEN RESORT HOTEL submitted their quotations for lot 3 and LUCILLA'S CATERING SERVICES, OPC, MAY'S ORGANIC GARDEN RESTAURANT, A&N EATERY and ROGER'S CUISINE submitted their quotations for lot 6.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, LUCILLA'S CATERING SERVICES, OPC and ZAMEO MULTI-PURPOSE COOPERATIVE are both considered as the lowest offeror for lot 1. However, LUCILLA'S CATERING SERVICES, OPC submitted documentary requirements is not certified true copy. Therefore, considered as non-responsive.

WHEREAS, ZAMEO MULTI-PURPOSE COOPERATIVE is considered as the lowest responsive offeror for lot 1 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, on lot 3 LUCILLA'S CATERING SERVICES, OPC and PARVANA INN & SUITES are both considered as the lowest offerors. However, LUCILLA'S CATERING SERVICES, OPC submitted documentary requirements is not certified true copy. Therefore, considered as non-responsive.

WHEREAS, PARVANA INN & SUITES is considered as the lowest responsive offeror for lot 3 and with price quotation within the ABC and it was found to be compliant with the



eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, ROGER'S CUISINE is considered as the lowest offeror for lot 6 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Catering Services for the conduct of Stakeholders Meeting in 21 AMIA Villages (by LOT) to ZAMBO MULTI-PURPOSE COOPERATIVE in the amount of Forty Six Thousand Four Hundred Forty Pesos Only (Php 46,440.00) for lot 1 and to PARVANA INN & SUITES in the amount of Thirty Three Thousand Five Hundred Forty Pesos Only (Php 33,540.00) for lot 3 and to ROGER'S CUISINE in the amount of Forty Nine Thousand Four Hundred Pesos Only (Php 49,400.00) for lot 6.
