

Procurement of Supply and Delivery of Catering Services for the conduct of Stakeholders Meeting in 21 AMIA Villages (by LOT)

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Catering Services for the conduct of Stakeholders Meeting in 21 AMIA Villages (by LOT) with an Approved Budget for the Contract (ABC) of Forty-Eight Thousand Six Hundred Pesos Only (Php 48,600.00) for lot 2 and Thirty-Six Thousand Nine Hundred Pesos Only (Php 36,900.00) for lot 4 and Twenty-Three Thousand Four Hundred Pesos Only (Php 23,400.00) for lot 5.

WHEREAS, on Feb. 28, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE; (2) VILLA CONSORCIA RESORT; (3) MARIBERT INLAND RESORT for lot 2 and (1) ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE; (2) BULO HILLSIDE INTEGRATED FARM; (3) ROSELO'S RESTOBAR for lot 4 and (1) ZEMKAMPS CHALET; (2) JM BACK PACKERS HOMETEL; (3) STARGAZER INN for lot 5.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:30 PM. on Mar. 4, 2025, ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE, VILLA CONSORCIA RESORT and MARIBERT INLAND RESORT submitted their quotations for lot 2 and to ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE, BULO HILLSIDE INTEGRATED FARM, ROSELO'S RESTOBAR for lot 4 and to ZEMKAMPS CHALET, JM BACK PACKERS HOMETEL, STARGAZER INN for lot 5.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, MARIBERT INLAND RESORT is considered as the lowest offeror for lot 2 and ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE for lot 4 and ZEMKAMPS CHALET for lot 5 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Catering Services for the conduct of Stakeholders Meeting in 21 AMIA Villages (by LOT) to MARIBERT INLAND RESORT in the amount of Forty Two Thousand Six Hundred Sixty Pesos Only (Php 42,660.00) for lot 2 and to ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE in the amount of Thirty Six Thousand Eighty Pesos Only (Php 36,080.00) for lot 4 and to ZEMKAMPS CHALET in the amount of Twenty One Thousand Three Hundred Twenty Pesos Only (Php 21,320.00) for lot 5.
