

BAC Resolution No. 000, Series of 2025

Procurement of Supply and Delivery of Catering Services for the conduct of Bench Marking to Outstanding Rural Women Farms with existing CRA Technologies and AMIA Villages at Bingawan, Iloilo, Dingle, Iloilo, Sagay City, Negros Occidental and Pontevedra, Capiz

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Catering Services for the conduct of Bench Marking to Outstanding Rural Women Farms with existing CRA Technologies and AMIA Villages at Bingawan, Iloilo, Dingle, Iloilo, Sagay City, Negros Occidental and Pontevedra, Capiz with an Approved Budget for the Contract (ABC) of One Hundred Thirty Four Thousand Five Hundred Pesos Only (Php 134,500.00) for lot 1 and Ninety Four Thousand One Hundred Fifty Pesos Only (Php 94,150.00) for lot 2.

WHEREAS, on Feb. 7, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) POLOY'S FOOD HUB; (2) DAMYSYL MARIE BERNARTE; (3) CONCEPCION CARILLO AGRICULTURAL FARM; (4) MAMBA BAR AND RESTAURANT for lot 1 and (1) MAY'S ORGANIC GARDEN RESTAURANT; (2) ROGER'S CUISINE; (3) GLENDA'S RESTAURANT for lot 2.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM, on Feb. 12, 2025, POLOY'S FOOD HUB, DAMYSYL MARIE BERNARTE, CONCEPCION CARILLO AGRICULTURAL FARM and MAMBA BAR AND RESTAURANT submitted their quotations for lot 1 and MAY'S ORGANIC GARDEN RESTAURANT, ROGER'S CUISINE, GLENDA'S RESTAURANT for lot 2.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, 1 and MAY'S ORGANIC GARDEN RESTAURANT for lot 2 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Catering Services for the conduct of Bench Marking to Outstanding Rural Women Farms with existing CRA Technologies and AMIA Villages at Bingawan, Iloilo, Dingle, Iloilo, Sagay City, Negros Occidental and Pontevedra, Capiz to CONCEPCION CARILLO AGRICULTURAL FARM in the amount of One Hundred Thirty Four Thousand Five Hundred Pesos Only (Php 134,500.00) for lot 1 and to MAY'S ORGANIC GARDEN RESTAURANT in the amount of Ninety Three Thousand Eight Hundred Pesos Only (Php 93,800.00) for lot 2.
