

BAC Resolution No. 0091, Series of 2025

Procurement of Vehicle Rental to be used for Monitoring in 21 AMIA Villages

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Vehicle Rental to be used for Monitoring in 21 AMIA Villages with an Approved Budget for the Contract (ABC) of Twenty Two Thousand Pesos Only (Php 22,500.00) for lot 1 and Eighteen Thousand Pesos Only (Php 18,500.00) for lot 2 and Twenty Two Thousand Pesos Only (Php 22,000.00) for lot 3 and Nineteen Thousand Pesos Only (Php 19,000.00) for lot 4 and Forty Thousand Pesos Only (Php 40,000.00) for lot 6.

WHEREAS, on Feb. 7, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) BENCH TRANSPORT SERVICES; (2) ISLAND ADVENTURE TOURS AND TRAVEL; (3) CBTMPC; (4) EXECUTIVE ELEGANCE CHARTERS, OPC; (5) CHERALD TOURS & TRAVEL & TOURS; (6) RJB STAR TRANSPORT

on Feb. 12, 2025, BENCH TRANSPORT SERVICES, ISLAND ADVENTURE TOURS AND TRAVEL, CB TMPC, EXECUTIVE ELEGANCE CHARTERS, OPC, CHERALD TRAVEL & TOURS and RJB STAR TRANSPORT submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, BENCH TRANSPORT SERVICES is considered as the lowest offeror for lot 1, 2, 3, 5 and 6 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGPS Registration Number.

WHEREAS, upon careful evaluation, BENCH TRANSPORT SERVICES and ISLAND ADVENTURE TOURS AND TRAVEL are both considered as the lowest offerors for lot 4. However, ADVENTURE TOURS AND TRAVEL submitted documentary requirements is not certified true copy. Therefore, considered as non-responsive.

WHEREAS, BENCH TRANSPORT SERVICES is considered as the lowest responsive offeror for lot 4 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Vehicle Rental to be used for Monitoring in 21 AMIA Villages to BENCH TRANSPORT SERVICES for lot 1 and in the amount of Sixteen Thousand Pesos Only (Php 16,900.00) for lot 2 and in the amount of Sixteen Thousand Pesos Only (Php 19,600.00) for lot 3 and in the amount of Twenty One Thousand and Eight Hundred Pesos Only (Php 21,800.00) for lot 4 and in the

amount of Eighteen Thousand Pesos Only (Php 18,000.00) for lot 4 and in the amount of  
Twelve Thousand Pesos Only (Php 12,000.00) for lot 5 and in the amount of Twenty  
Eight Thousand Pesos Only (Php 28,000.00) for lot 6.
