

Procurement and Delivery of Garden Tools and Materials

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement and Delivery of Garden Tools and Materials with an Approved Budget for the Contract (ABC) of One Hundred Seventeen Thousand Five Hundred Pesos Only (Php 117,500.00).

WHEREAS, on Feb. 10, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) MAGNA MATIC MKTG.; (2) ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC.; (3) ILOILO FAITH ENTERPRISES & GEN. MANPOWER SERVICES INC.; (4) JUANTONG AGRI-VENTURES, INC.; (5) NEW HONG CHIU HARDWARE; (6) THREE N' ONE ENTERPRISES

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 17, 2025, MAGNA MATIC MKTG., ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC., ILOILO FAITH ENTERPRISES & GEN. MANPOWER SERVICES INC., JUANTONG AGRI-VENTURES, INC., NEW HONG CHIU HARDWARE and THREE N' ONE ENTERPRISES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, JUANTONG AGRI-VENTURES, INC. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by JUANTONG AGRI-VENTURES, INC. in the amount of Seventy-Nine Thousand Eight Hundred Eighty Pesos Only (Php 79,880.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement and Delivery of Garden Tools and Materials to JUANTONG AGRI-VENTURES, INC. in the amount of Seventy-Nine Thousand Eight Hundred Eighty Pesos Only (Php 79,880.00).
