**BAC Resolution No. 0382, Series of 2025**

**One Job Order for encoding, lay outing, editing and printing of High Value Crops Development Program (HVCDP) IEC materials**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the One Job Order for encoding, lay outing, editing and printing of High Value Crops Development Program (HVCDP) IEC materials with an Approved Budget for the Contract (ABC) of Sixty-Two Thousand Pesos Only (Php 62,000.00).

**WHEREAS**, on Feb. 17, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ILOILO PRINTING AND SERVICES; (2) MAKINAUGALINGON PRINTER & BOOKBINDER; (3) NO BOUNDARIES ADVERTISING AND EVENTS

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 24, 2025, ILOILO PRINTING AND SERVICES, MAKINAUGALINGON PRINTER & BOOKBINDER and NO BOUNDARIES ADVERTISING AND EVENTS submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ILOILO PRINTING AND SERVICES is considered as the lowest offeror. However, the suppliers submitted Omnibus Sworn Statement is not original and did not meet the delivery period required. Therefore, considered as non-responsive.

**WHEREAS**, NO BOUNDARIES ADVERTISING AND EVENTS is considered as the lowest responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by NO BOUNDARIES ADVERTISING AND EVENTS in the amount of Forty-Four Thousand Seven Hundred Fifty Pesos Only (Php 44,750.00) is the lowest responsive quotation.

**WHEREAS** the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant. **WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the One Job Order for encoding, lay outing, editing and printing of High Value Crops Development Program (HVCDP) IEC materials to NO BOUNDARIES ADVERTISING AND EVENTS in the amount of Forty-Four Thousand Seven Hundred Fifty Pesos Only (Php 44,750.00).
