

Procurement of Supply and Delivery of Catering Services for the conduct of Human Resource Training Activities for CY 2025

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Catering Services for the conduct of Human Resource Training Activities for CY 2025 with an Approved Budget for the Contract (ABC) of Four Hundred Three Thousand Seven Hundred Fifty Pesos Only (Php 403,750.00).

WHEREAS, on February 21, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) JTC GOLDENFOOD VENTURES CORP.; (2) J & P CANTINA; (3) CK TRUMART FOODS CORPORATION; (4) OCTAPRIME INFINITY FOODS CORP;

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on February 25, 2025, JTC GOLDENFOOD VENTURES CORP., J & P CANTINA, CK TRUMART FOODS CORPORATION and OCTAPRIME INFINITY FOODS CORP submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, J & P CANTINA is considered as the lowest offeror and with price quotation within the ABC and was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, on February 27, 2025, the End-User, express its concern regarding J & P CANTINA thru a letter regarding the services it provided. They want to address certain concerns such as: Inaccurate Order Fulfillment; Hygiene Concerns; Timeliness issues and Lack of Responsiveness to Feedback which they find very relevant in the services they need in all their scheduled activity (Annex A).

WHEREAS, the Bids and Awards Committee thru its BAC Chairperson, decided to proceed the award of contract to the 2nd Lowest offeror, CK TRUMART FOODS CORPORATION, with price quotation within the ABC and was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract to CK TRUMART FOODS CORPORATION for the Procurement of Supply and Delivery of Catering Services for the conduct of Human Resource Training Activities for CY 2025 in the amount of Four Hundred Thousand One Hundred Eighty-Seven Pesos and 50/100 (Php 400,187.50).
