**WHEREAS**, the Department of Agriculture has a Purchase Request for the Procurement of Supply & Delivery of Banana Sucker for FY 2025 with an Approved Budget for the Contract (ABC) of Sixty Seven Thousand Five Hundred Pesos Only (Php 67,500.00).

**WHEREAS**, on January 14, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) JUANTONG AGRI VENTURES, INC. (2) MUEGAS MAGLANTAY AGRICULTURAL SUPPLY.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 pm. On January 21, 2025, JUANTONG AGRI VENTURES, INC.; (2) MUEGAS MAGLANTAY AGRICULTURAL SUPPLY. submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, JUANTONG AGRI VENTURES, INC. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by JUANTONG AGRI VENTURES, INC. in the amount of Fifty Nine Thousand Five Hundred Pesos Only (Php59,500.00) is the lowest quotation.
