**BAC Resolution No. 0119, Series of 2025**

**Provision for Food and Accommodation for Orientation and coordination activities of DA-4K NPMO with partner stakeholders**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Provision for Food and Accommodation for Orientation and coordination activities of DA-4K NPMO with partner stakeholders with an Approved Budget for the Contract (ABC) of Two Hundred Twenty Thousand Pesos Only (Php 220,000.00) for lot 1 and Fifty Thousand Pesos Only (Php 50,000.00) for lot 2 and Seventy Two Thousand Pesos Only (Php 72,000.00) for lot 3 and Twenty Nine Thousand One Hundred Pesos Only (Php 29,100.00) for lot 4.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 25, 2025, AMIGO SCOTT'S MANAGEMENT INC., ZURI HOTELS AND SUITES, DIVERSION 21 HOTEL submitted their quotations for lot 1 and MARZON HOTEL, HOTEL METRO AND SKY BAR RESTAURANT, GQ PLAZA for lot 2 and O HOTEL, BACOLOD REAL ESTATE DEVELOPMENT CORPORATION, L.FISHER HOTEL for lot 3 and ZAYCOLAND, HOTEL DEL SUR, BLAS RESTOBAR for lot 4.
