WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Mar. 3, 2025, J&P CANTINA, INC., BREAD BASKET BREAD AND PASTRIES SHOP, NUTRENDS CUISINE CATERING SERVICES, ILOILO PROVINCIAL EMPLOYEES & COMMUNITY MPC and KRS CATERING & SERVICES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ILOILO PROVINCIAL EMPLOYEES & COMMUNITY MPC is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
