

**BAC Resolution No. 019, Series of 2025**

**Provision of Food and Accommodation during the conduct of various activities of the Market Development Section at Negros Occidental/ Negros Island Region**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Provision of Food and Accommodation during the conduct of various activities of the Market Development Section at Negros Occidental/ Negros Island Region with an Approved Budget for the Contract (ABC) of Two Hundred Fifty-Eight Thousand Two Hundred Ninety Pesos Only (Php 258,290.00).

**WHEREAS**, on Jan. 31, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) RFC METRO INN; (2) MOZ WESTOWN HOTEL & CONVENTION HALL; (3) MAY'S ORGANIC GARDEN RESTAURANT

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb., 2025, RFC METRO INN, MOZ WESTOWN HOTEL & CONVENTION HALL, and MAY'S ORGANIC GARDEN RESTAURANT submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, MOZ WESTOWN HOTEL & CONVENTION HALL and MAY'S ORGANIC GARDEN RESTAURANT are both considered as the lowest offerors. However, MAY'S ORGANIC GARDEN RESTAURANT submitted Request for Quotation is dated on January 21, 2025 which does not coincide with the latest date in which the RFQ was posted in the PhilGEPS Website. Therefore, considered as non-responsive.

**WHEREAS**, MOZ WESTOWN HOTEL & CONVENTION HALL is considered as the lowest responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Provision of Food and Accommodation during the conduct of various activities of the Market Development Section at Negros Occidental/ Negros Island Region to MOZ WESTOWN HOTEL & CONVENTION HALL in the amount of Two Hundred Fifty-Five Thousand Eight Hundred Fifty Pesos Only (Php 255,850.00).
