

**BAC Resolution No. 0079, Series of 2025**

**Procurement of Supplies and Materials for the production of biological control agents**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Procurement of Supplies and Materials for the production of biological control agents with an Approved Budget for the Contract (ABC) of Two Hundred Thirty Thousand Pesos Only (Php 230,000.00).

**WHEREAS**, on Jan. 20, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) THREE N' ONE ENTERPRISES; (2) D'MALT INDUSTRIAL SALES CORP.; (3) JUANTONG AGRI-VENTURES, INC.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 PM. on Jan. 27, 2025, THREE N' ONE ENTERPRISES, D'MALT INDUSTRIAL SALES CORP. and JUANTONG AGRI-VENTURES, INC. submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, JUANTONG AGRI-VENTURES, INC. is considered as the lowest offeror. However, the supplier has no brand offered. Therefore, considered as non-responsive.

**WHEREAS**, THREE N' ONE ENTERPRISES is considered as the lowest responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by THREE N' ONE ENTERPRISES in the amount of Two Hundred Twenty-Six Thousand Six Hundred Pesos Only (Php 226,600.00) is the lowest responsive quotation.

**WHEREAS** the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant

**WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supplies and Materials for the production of biological control agents to THREE N' ONE ENTERPRISES in the amount of Two Hundred Twenty-Six Thousand Six Hundred Pesos Only (Php 226,600.00).
