

WHEREAS, the Department of Agriculture has a Purchase Request for the Provision for Van Rental (Lot 3) with an Approved Budget for the Contract (ABC) of Forty Thousand Pesos Only (Php 40,000.00).

WHEREAS, on Jan. 20, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) RJ TRANSPORT SERVICES; (2) SOUTHWEST TOURS; (3) BENNCH TRANSPORT SERVICES; (4) ISLAND ADVENTURE TOURS & TRAVEL; (5) 75Q OPC

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM, on Jan. 27, 2025, RJ TRANSPORT SERVICES, SOUTHWEST TOURS, BENNCH TRANSPORT SERVICES, ISLAND ADVENTURE TOURS & TRAVEL and 75Q OPC submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, RJ TRANSPORT SERVICES is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
