**BAC Resolution No. 014, Series of 2025**

**Procurement of Food for the Implementation of Various Activities of 4K Program**

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Food for the Implementation of Various Activities of 4K Program with an Approved Budget for the Contract (ABC) of One Hundred Three Thousand Four Hundred Pesos Only (Php 103,300.00) for lot 1 and Ninety-Six Thousand and Four Hundred Pesos Only (Php 96,400.00) for lot 2 and Fifty-One Thousand Six Hundred Fifty Pesos Only (Php 51,650.00) for lot 3 and Fifty-Eight Thousand Five Hundred Fifty Pesos Only (Php 58,550.00) for lot 4.

WHEREAS, on Jan. 27, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ENTING'S; (2) ALVEL'S CATERING; (3) GLENDA'S RESTAURANT for lot 1 and to (1) PAULCA DHASH RESTAURANT AND CATERING; (2) FLAVORRA CATERING SERVICES; (3) TRICIA CATERING SERVICES for lot 2 and to (1) GERRY ROXAS FOUNDATION, INC.; (2) NESTAS HILLTOP HOTEL & RESTAURANT; (3) MP STAR CORPORATION for lot 3 and to (1) EDEN RESORT HOTEL; (2) PARVANA INN & SUITES; (3) DIEGO CARINDERIA for lot 4.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 3, 2025, ENTING'S, ALVEL'S CATERING and GLENDA'S RESTAURANT submitted their quotations for lot 1 and PAULCA DHASH RESTAURANT AND CATERING, FLAVORRA CATERING SERVICES, TRICIA CATERING SERVICES for lot 2 and GERRY ROXAS FOUNDATION, INC., NESTAS HILLTOP HOTEL & RESTAURANT, MP STAR CORPORATION for lot 3 and EDEN RESORT HOTEL, PARVANA INN & SUITES, DIEGO CARINDERIA for lot 4.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, GLENDA'S RESTAURANT is considered as the lowest offeror for lot 1 and TRICIA CATERING SERVICES for lot 2 and GERRY ROXAS FOUNDATION, INC. for lot 3 and PARVANA INN & SUITES for lot 4 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Food for the Implementation of Various Activities of 4K Program to GLENDA'S RESTAURANT in the amount of Ninety-Three Thousand Seven Hundred Fifty Pesos Only (Php 93,750.00) for lot 1 and to TRICIA CATERING SERVICES in the amount of Ninety-Five Thousand Five Hundred Fifty Pesos Only (Php 95,550.00) for lot 2 and to GERRY ROXAS FOUNDATION, INC. in the amount of Fifty-One Thousand Six Hundred Fifty Pesos Only (Php 51,650.00) for lot 3 and to PARVANA INN & SUITES in the amount of Fifty-Seven Thousand Seven Hundred Fifty Pesos Only (Php 57,750.00) for lot 4.
