**BAC Resolution No. 0172, Series of 2025**

**Procurement of Supply and Delivery of Re-Certification of Biosafety Cabinet and PCR Cabinet (ESCO)**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Re-Certification of Biosafety Cabinet and PCR Cabinet (ESCO) with an Approved Budget for the Contract (ABC) of Sixty-Five Thousand Pesos Only (Php 65,000.00).

**WHEREAS**, on Feb. 3, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) OMNIBUS BIO-MEDICAL SYSTEMS, INC.; (2) MICROGENETIX INC.; (3) ESCO PHILIPPINES INC.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 10, 2025, OMNIBUS BIO-MEDICAL SYSTEMS, INC., MICROGENETIX INC. and ESCO PHILIPPINES INC. submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ESCO PHILIPPINES INC. is considered as the lowest offeror and with price quotation within the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by ESCO PHILIPPINES INC. in the amount of Fifty-Nine Thousand Three Hundred Sixty Pesos Only (Php 59,360.00) is the lowest quotation.

**WHEREAS** the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant

**WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the Supply and Delivery of Re-Certification of Biosafety Cabinet and PCR Cabinet (ESCO) to ESCO PHILIPPINES INC. in the amount of Fifty-Nine Thousand Three Hundred Sixty Pesos Only (Php 59,360.00).
