Lease of Venue, Food and Accommodation during the conduct of
Strengthening/Capability Building of KADIWA Suppliers/FCAs at Iloilo City

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue, Food and Accommodation during the conduct of Strengthening/Capability Building of KADIWA Suppliers/FCAs at Iloilo City with an Approved Budget for the Contract (ABC) of One Hundred Sixty-Three Thousand Nine Hundred Pesos Only (Php 163,900.00).

WHEREAS, on March 21, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) HARBOR TOWN HOTEL MANAGEMENT CORPORATION; (2) GRAND XING IMPERIAL HOTEL; (3) THE CAPITOL PLACE ILOILO INC.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on March 28, 2025, HARBOR TOWN HOTEL MANAGEMENT CORPORATION, GRAND XING IMPERIAL HOTEL and THE CAPITOL PLACE ILOILO INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, HARBOR TOWN HOTEL MANAGEMENT CORPORATION is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NCW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lease of Venue, Food and Accommodation during the conduct of Strengthening/Capability Building of KADIWA Suppliers/FCAs at Iloilo City to HARBOR TOWN HOTEL MANAGEMENT CORPORATION in the amount of One Hundred Fifty-Nine Thousand Eight Hundred Ninety Pesos Only (Php 159,890.00).
