



**BAC Resolution No. 0211, Series of 2025**

**Lease of Venue with Food and Accommodation for the various activities of Research Division for CY 2025- Lot 1**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation for the various activities of Research Division for CY 2025- Lot 1 with an Approved Budget for the Contract (ABC) of Nine Hundred Sixteen Thousand Pesos Only (Php 916,000.00).

**WHEREAS**, on February 20, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) EON REALTY AND DEVELOPMENT CORPORATION; (2) ZURI HOTELS AND RESORT CORPORATION; (3) MO2 WESTOWN HOTEL

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 pm. on February 27, 2025, EON REALTY AND DEVELOPMENT CORPORATION, ZURI HOTELS AND RESORT CORPORATION and MO2 WESTOWN HOTEL submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, MO2 WESTOWN HOTEL is considered as the lowest offeror but due to erasure/alteration on the unit cost where it is stated in the number 3 of the Request for Quotation, the offer shall be rendered invalid. Whereas, EON REALTY AND DEVELOPMENT CORPORATION is considered as the second lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lease of Venue with Food and Accommodation for the various activities of Research Division for CY 2025- Lot 1 to EON REALTY AND DEVELOPMENT CORPORATION in the amount of Eight Hundred Ninety-One Thousand Pesos Only (Php 891,000.00).
