

BAC Resolution No. 0244, Series of 2025

LOV of Food and Accommodation during the conduct of Orientation/Briefing of the Kadiwa Program with LGUs in W. Visayas on April 15-16, 2025 in Iloilo City

WHEREAS, the Department of Agriculture has a Purchase Request for the LOV of Food and Accommodation during the conduct of Orientation/Briefing of the Kadiwa Program with LGUs in W. Visayas on April 15-16, 2025 in Iloilo City with an Approved Budget for the Contract (ABC) of Two Hundred Sixty Thousand Pesos Only (Php 260,000.00).

WHEREAS, on March 17, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) DISTRICT 21 HOTEL; (2) SAMS 21 HOTEL; (3) DIVERSION 21 HOTEL.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on March 20, 2025, DISTRICT 21 HOTEL, SAMS 21 HOTEL and DIVERSION 21 HOTEL submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, SAMS 21 HOTEL is considered as the lowest offeror and with price quotation within the ABC but due to an alteration in the unit cost and total cost, their offer shall be rendered invalid. However, DISTRICT 21 HOTEL will be considered as the second offeror since they were found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the LOV of Food and Accommodation during the conduct of Orientation/Briefing of the Kadiwa Program with LGUs in W. Visayas on April 15-16, 2025 in Iloilo City to DISTRICT 21 HOTEL in the amount of Two Hundred Sixty Thousand Pesos Only (Php 260,000.00).
