

BAC Resolution No. 0145, Series of 2025

Procurement of Advocacy materials for various activities of 4K program

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Advocacy materials for various activities of 4K program with an Approved Budget for the Contract (ABC) of Four Hundred Eighty-Four Thousand Five Hundred Seventy-Five Pesos Only (Php 484,575.00).

WHEREAS, on Feb. 6, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ARTJUANA DESIGNS AND PROMOS INC.; (2) THREE N' ONE ENTERPRISES; (3) HOMEPRINTS COMMERCIAL OPC; (4) CLEAR IMAGE ADVERTISING; (5) ELLITE DIGITAL PRINTING SERVICES; (6) DATALEX ADVERTISING SERVICES

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 13, 2025, ARTJUANA DESIGNS AND PROMOS INC., THREE N' ONE ENTERPRISES, HOMEPRINTS COMMERCIAL OPC, CLEAR IMAGE ADVERTISING, ELLITE DIGITAL PRINTING SERVICES and DATALEX ADVERTISING SERVICES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ARTJUANA DESIGNS AND PROMOS INC. is considered as the lowest offeror. However, the suppliers submitted Mayor's Permit is expired. Therefore, considered as non-responsive.

WHEREAS, HOMEPRINTS COMMERCIAL OPC is considered as the lowest responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by HOMEPRINTS COMMERCIAL OPC in the amount of Four Hundred Seventy Thousand Five Hundred Pesos Only (Php 470,500.00) is the lowest responsive quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Advocacy materials for various activities of 4K program to HOMEPRINTS COMMERCIAL OPC in the amount of Four Hundred Seventy Thousand Five Hundred Pesos Only (Php 470,500.00).
