BAC Resolution No. 0289, Series of 2025

Procurement of Supply and Delivery of Laboratory Chemicals

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Laboratory Chemicals with an Approved Budget for the Contract (ABC) of Six Hundred Ninety-Five Thousand One Hundred Sixty-Five Pesos Only (Php 695,165.00).

WHEREAS, on Feb. 12, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) KRYPTON INTERNATIONAL RESOURCES SALES & SERVICES, INC.; (2) REVTECHNOLOGIES CO.; (3) EAGLEWINGS ENTERPRISES INC.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 19, 2025, KRYPTON INTERNATIONAL RESOURCES SALES & SERVICES, INC., REVTECHNOLOGIES CO. and EAGLEWINGS ENTERPRISES INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specifications stated in the Request for Quotation, KRYPTON INTERNATIONAL RESOURCES SALES & SERVICES, INC. is considered as the lowest of price and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilREPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by KRYPTON INTERNATIONAL RESOURCES SALES & SERVICES, INC. in the amount of Four Hundred Eighty-Seven Thousand Nine Hundred Ten Pesos Only (Php 487,910.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant. WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NO W, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Laboratory Chemicals to KRYPTON INTERNATIONAL RESOURCES SALES & SERVICES, INC. in the amount of Four Hundred Eighty-Seven Thousand Nine Hundred Ten Pesos Only (Php 487,910.00).
