

BAC Resolution No. 0145, Series of 2025

Procurement and Delivery of seeds and materials for vegetable production and agrimarine inputs (lot 2)

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement and Delivery of seeds and materials for vegetable production and agrimarine inputs (lot 2) with an Approved Budget for the Contract (ABC) of Two Hundred Eighty-Two Thousand Fifty Pesos Only (Php 282,050.00).

WHEREAS, on Feb. 17, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) RS AGRO INDUSTRIAL CORP.; (2) KMK AGRI PRODUCTS TRADING; (3) ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC.; (4) JUAN TONG AGRI-VENTURES, INC.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM, on Feb. 24, 2025, RS AGRO INDUSTRIAL CORP., KMK AGRI PRODUCTS TRADING, ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC. and JUAN TONG AGRI-VENTURES, INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, JUAN TONG AGRI-VENTURES, INC. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by JUAN TONG AGRI-VENTURES, INC. in the amount of Two Hundred Seventy-Eight Thousand Two Hundred Sixty-Seven Pesos Only (Php 278,267.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant **WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement and Delivery of seeds and materials for vegetable production and agrimarine inputs (lot 2) to JUAN TONG AGRI-VENTURES, INC. in the amount of Two Hundred Seventy-Eight Thousand Two Hundred Sixty-Seven Pesos Only (Php 278,267.00).
