BAC Resolution No. 0248, Series of 2025

Procurement of Supply and Delivery of Bathroom Mirror

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Bathroom Mirror with an Approved Budget for the Contract (ABC) of Seventy-Five Thousand Six Hundred Pesos Only (Php 75,600.00).

WHEREAS, on Feb. 20, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) BABA BUILDERS OPC; (2) J.C. ALABASON BUILDERS AND SUPPLY; (3) QUADRO AMIGOS BUILDERS & SUPPLY; (4) NOE'S BUILDERS; (5) GATS AND SON CONSTRUCTION DEVELOPMENT CO.; (6) JUANTONG & SONS BUILDER CORP.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 27, 2025, BABA BUILDERS OPC, J.C. ALABASON BUILDERS AND SUPPLY, QUADRO AMIGOS BUILDERS & SUPPLY, NOE'S BUILDERS, GATS AND SON CONSTRUCTION DEVELOPMENT CO. and JUANTONG & SONS BUILDER CORP. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, JUANTONG & SONS BUILDER CORP. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by JUANTONG & SONS BUILDER CORP. in the amount of Forty-Seven Thousand Three Hundred Twenty Pesos Only (Php 47,320.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant. WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Bathroom Mirror to JUANTONG & SONS BUILDER CORP. in the amount of Forty-Seven Thousand Three Hundred Twenty Pesos Only (Php 47,320.00).
