Procurement of Supply and Delivery Office Equipment

WHEREAS, the Department of Agriculture has a Purchase Request for the

Procurement of Supply and Delivery Office Equipment with an Approved Budget for the Contract (ABC) of Sixty-Four Thousand Nine Hundred Pesos Only (Php 64,900.00).

WHEREAS, on Feb. 24, 2025, the BAC, thru its Secretariat, initiated the procurement

activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) THREE N' ONE ENTERPRISES; (2) CHE ENTERPRISE; (3) RICHMART

ENTERPRISES

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 P.M.

on Mar. 3, 2025, THREE N' ONE ENTERPRISES, CHE ENTERPRISE and RICHMART

ENTERPRISES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the

documentary requirements and specification stated in the Request for Quotation, THREE N' ONE ENTERPRISES is considered as the lowest offeror and with price quotation within

the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS

Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by

THREE N' ONE ENTERPRISES in the amount of Sixty Thousand Pesos Only (Php

60,000.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the

technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached

hereto as Annex "A," and made an integral part hereof.

NOVI, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after

duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of

Supply and Delivery Office Equipment to THREE N' ONE ENTERPRISES in the amount

of Sixty Thousand Pesos Only (Php 60,000.00).
