

BAC Resolution No. 0320, Series of 2025

Procurement of Training Supplies for Masagana Rice Development Program in

Western Visayas

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Training Supplies for Masagana Rice Development Program in Western Visayas with an Approved Budget for the Contract (ABC) of Eight Hundred Sixteen Thousand Pesos Only (Php 816,000.00).

WHEREAS, on Feb. 27, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) YORO'S CONSUMER GOODS TRADING; (2) KNOA OFFICE SUPPLIES AND EQUIPMENT TRADING; (3) HOMEPRINTS OFFICE SUPPLIES & EQUIPMENT

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Mar. 6, 2025, YORO'S CONSUMER GOODS TRADING, KNOA OFFICE SUPPLIES AND EQUIPMENT TRADING and HOMEPRINTS OFFICE SUPPLIES & EQUIPMENT submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, YORO'S CONSUMER GOODS TRADING is considered as the lowest offeror. However, the suppliers submitted documentary requirements is not certified true copy. Therefore, considered as non-responsive.

WHEREAS, HOMEPRINTS OFFICE SUPPLIES & EQUIPMENT is considered as the responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by HOMEPRINTS OFFICE SUPPLIES & EQUIPMENT in the amount of Three Hundred Ninety-Nine Thousand One Hundred Twenty-Two Pesos Only (Php 399,122.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant. WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Training Supplies for Masagana Rice Development Program in Western Visayas to HOMEPRINTS OFFICE SUPPLIES & EQUIPMENT in the amount of Three Hundred Ninety-Nine Thousand One Hundred Twenty-Two Pesos Only (Php 399,122.00).
