

BAC Resolution No. 026, Series of 2025

Procurement of Supply and Delivery of Plow and Harrow

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Plow and Harrow with an Approved Budget for the Contract (ABC) of Six Hundred Seventy-Two Thousand Pesos Only (Php 672,000.00);

WHEREAS, on January 27, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) NEW HONG CHIU HARDWARE; (2) RS AGRO INDUSTRIAL CORP.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on February 03, 2025, NEW HONG CHIU HARDWARE and RS AGRO INDUSTRIAL CORP. submitted their quotations.

WHEREAS, upon careful evaluation, selection, and verification of all the documentary requirements and specification stated in the Request for Quotation, RS AGRO INDUSTRIAL CORP. is considered as the lowest bidder, and with price quotation within the ABC but due to incomplete supporting documents, their offer shall be rendered invalid. However, NEW HONG CHIU HARDWARE will be considered as the second offeror since they were found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of valid HiligEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOP for its consideration and approval, the award of contract for the Procurement of Supply and Delivery of Plow and Harrow to NEW HONG CHIU HARDWARE in the amount of Six Hundred Seventy-Two Thousand Eight Hundred Pesos Only (Php 632,800.00).
