

BAC Resolution No. 0215, Series of 2025
Procurement of Vehicle Rental to be used for the conduct of Stakeholders Meeting in 21 AMIA Villages

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Vehicle Rental to be used for the conduct of Stakeholders Meeting in 21 AMIA Villages with an Approved Budget for the Contract (ABC) of Seventeen Thousand Five Hundred Pesos Only (Php 17,500.00) for lot 1 and Twenty Four Thousand Pesos Only (Php 24,000.00) for lot 2 and Twelve Thousand Pesos Only (Php 12,000.00) for lot 3 and Twenty One Thousand Pesos Only (Php 21,000.00) for lot 4 and Fourteen Thousand Pesos Only (Php 14,000.00) for lot 5 and Thirty Thousand Pesos Only (Php 30,000.00) for lot 6.

WHEREAS, on Mar. 14, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) BENNCH TRANSPORT SERVICES; (2) EXECUTIVE ELEGANCE CHARTERS, OPC; (3) RJ TRANSPORT SERVICES for lot 1, 2, 3, 4, 5 and 6.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Mar. 17, 2025, BENNCH TRANSPORT SERVICES, EXECUTIVE ELEGANCE CHARTERS, OPC and RJ TRANSPORT SERVICES submitted their quotations for the lots.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, RJ TRANSPORT SERVICES is considered as the lowest offeror for lot 1, 3, 4 and 5 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, BENNCH TRANSPORT SERVICES is considered as the lowest offeror for lot 2 and 6 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Vehicle Rental to be used for the conduct of Stakeholders Meeting in 21 AMIA Villages to RJ TRANSPORT SERVICES in the amount of Fifteen Thousand Six Hundred Sixty Five Pesos Only (Php 15,665.00) for lot 1 and in the amount of Ten Thousand Seven Hundred Seventy Seven Pesos Only (Php 10,777.00) for lot 3 and in the amount of Seventeen Thousand Five Hundred Nine Three Pesos Only (Php 17,553.00) for lot 4 and in the amount of Eleven Thousand Nine Hundred Ninety Eight Pesos Only (Php 11,998.00) for lot 5 and to BENNCH TRANSPORT SERVICES in the amount of Twenty Two Thousand Pesos Only (Php 22,000.00) for lot 2 and in the amount of Twenty One Thousand Pesos Only (Php 21,000.00) for lot 6.
