

BAC Resolution No. 0247, Series of 2025

Procurement of Blinds for DA-Western Visayas New Building (Perimeter Only)

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Blinds for DA-Western Visayas New Building (Perimeter Only) with an Approved Budget for the Contract (ABC) of Eight Hundred Seventy-Five Thousand Pesos Only (Php 875,000.00).

WHEREAS, on Mar. 13, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) MCAST CONSTRUCTION SERVICES; (2) COCCYX COMPUTER SALES & SERVICES; (3) RM MOONSTONE CONSTRUCTION

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Mar. 17, 2025, MCAST CONSTRUCTION SERVICES, COCCYX COMPUTER SALES & SERVICES and RM MOONSTONE CONSTRUCTION submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, MCAST CONSTRUCTION SERVICES is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by MCAST CONSTRUCTION SERVICES in the amount of Seven Hundred Seventy-Four Thousand and Five Hundred Sixty Pesos Only (Php 774,560.00) is the lowest quotation. WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof. NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Blinds for DA-Western Visayas New Building (Perimeter Only) to MCAST CONSTRUCTION SERVICES in the amount of Seven Hundred Seventy-Four Thousand and Five Hundred Sixty Pesos Only (Php 774,560.00).




