

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Chiller, Impulse Sealer, Banana slicer & Chest Freezer to JUAN TONG AGRI-VENTURES, INC. in the amount of Five Hundred Twenty-Nine Thousand Seven Hundred Seventy-Two Pesos Only (Php 529,772.00).

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, J MARKETING CORPORATION is considered as the lowest offeror and with price quotation within the ABC but due to incomplete supporting documents and no brand offer, their offer shall be rendered invalid. 


