Provision for Food and Catering Services for the conduct of various activities of ICM package of technology in Sigma, Capiz

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ZAMEO MULTI-PURPOSE COOPERATIVE is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
