Provision for Food and Catering Services for the conduct of various Trainings, Activities and Field Day of Research Division for CY 2025 (lot 1)

WHEREAS, the Department of Agriculture has a Purchase Request for the Provision for Food and Catering Services for the conduct of various Trainings, Activities and Field Day of Research Division for CY 2025 (lot 1) with an Approved Budget for the Contract (ABC) of Three Hundred Forty-Nine Thousand Two Hundred Thirty Pesos Only (Php 349,230.00).
