Provision of Additional Two (2) Outsourced Janitorial Services for the Period of April to December 2025 to be assigned at DA-WV New Building

WHEREAS, the Department of Agriculture has a Purchase Request for the Provision of Additional Two (2) Outsourced Janitorial Services for the Period of April to December 2025 to be assigned at DA-WV New Building with an Approved Budget for the Contract (ABC) of Three Hundred Thirty-Two Thousand One Hundred Twenty-Five Pesos & 02/100 Only (Php 332,125.02).

WHEREAS, on Apr. 8, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ROYAL 88 MANPOWER SERVICES; (2) TEKTON ENTRE-VOISERS COOPERATIVE ILOILO; (3) GRAN SPREE MANPOWER SERVICES

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM, on Apr. 11, 2025, ROYAL 88 MANPOWER SERVICES, TEKTON ENTRE-VOISERS COOPERATIVE ILOILO and GRAN SPREE MANPOWER SERVICES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of the documentary requirements and specification stated in the Request for Quotation, ROYAL 88 MANPOWER SERVICES is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Provision of Additional Two (2) Outsourced Janitorial Services for the Period of April to December 2025 to be assigned at DA-WV New Building to ROYAL 88 MANPOWER SERVICES in the amount of Three Hundred Twenty-Nine Thousand Three Hundred Sixty Pesos & 76/100 Only (Php 329,360.76).
