(Small Value Procurement)

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Catering Services for various activities under Field Operations Division with an Approved Budget for the Contract (ABC) of One Million Three Hundred Twenty-Six Thousand Four Hundred Fifty Pesos Only (Php 1,326,450.00);

WHEREAS, on April 17, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) Eon Centennial Resort Hotel & Waterpark; (2) Iloilo Provincial Employees and Community Multipurpose Cooperative; (3) JP Cantina, Inc.;

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 P.M. on, April 22, 2025, Eon Centennial Resort Hotel & Waterpark, Iloilo Provincial Employees and Community Multipurpose Cooperative & JP Cantina, Inc., submitted their quotations;

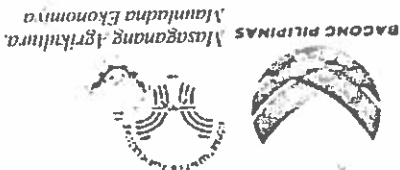
WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, Iloilo Provincial Employees and Community Multipurpose Cooperative are considered as the lowest offerors. However, Iloilo Provincial Employees and Community Multipurpose Cooperative did not comply the documentary requirements for validation. Therefore, considered non-responsive.

WHEREAS, Eon Centennial Resort Hotel & Waterpark is the 2nd lowest responsive offeror with price quotation within the ABC and it was found to be compliant with the checklist of eligibility technical requirements as evidenced by the submission of all documents required.




