WHEREAS, the Department of Agriculture has a Purchase Request for the Food during the conduct of Participatory Rural Appraisal to SAAD beneficiaries in the Province of Antique and Aklan for FY 2025- Lot 3 Contract (ABC) of One Hundred Seventy-Six Thousand Nine Hundred Pesos Only (Php 176,900.00).

WHEREAS, on March 5, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) D'BUSAY RESORT; (2) NAMITTURN EATERY; (3) 3 KING AND GRACE RESTAURANT.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements; and specification stated in the Request for Quotation, D'BUSAY RESORT is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
