WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Other Supplies for 2025 with an Approved Budget for the Contract (ABC) of Two Hundred Thousand Pesos Only (Php 200,000.00). WHEREAS, on Jan. 30, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) BLUE BAUX CORP., (2) PLANTERS TRADING AGRO SERVICES; (3) SI RAN AGRICULTURAL PRODUCTS & LIVESTOCK

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 6, 2025, BLUE BAUX CORP., PLANTERS TRADING AGRO SERVICES and SI RAN AGRICULTURAL PRODUCTS & LIVESTOCK submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation BLUE BAUX CORP. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by BLUE BAUX CORP. in the amount of One Hundred Ninety-Six Thousand Nine Hundred Thirty Pesos Only (Php 196,930.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant. WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

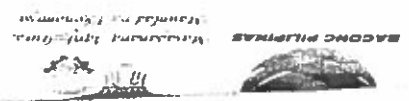
