Procurement of Works for the Expansion of Working Area in Bokashi Facility with Gender Sensitive Comfort Room

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Works for the Expansion of Working Area in Bokashi Facility with Gender Sensitive Comfort Room with an Approved Budget for the Contract (ABC) of Nine Hundred Thousand Pesos Only (Php 900,000.00).

WHEREAS, on Feb. 3, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the prospective suppliers related to the said procurement

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 10, 2025, SDB STEELSTRUCT BUILDERS ENTERPRISES submitted a quotation.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, SDB STEELSTRUCT BUILDERS ENTERPRISES is considered a responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by SDB STEELSTRUCT BUILDERS ENTERPRISES in the amount of Eight Hundred Ninety-Nine Thousand Eight Hundred Six Pesos & 60/100 Only (Php 899,806.50) is a responsive quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Works for the Expansion of Working Area in Bokashi Facility with Gender Sensitive Comfort Room to SDB STEELSTRUCT BUILDERS ENTERPRISES in the amount of Eight Hundred Ninety-Nine Thousand Eight Hundred Six Pesos & 60/100 Only (Php 899,806.60).
