BAC Resolution No. 0134, Series of 2025

Procurement of Supply and Delivery of Bagging Material

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Bagging Material with an Approved Budget for the Contract (ABC) of Three Hundred Thousand Pesos Only (Php 300,000.00).

WHEREAS, on Feb. 4, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ARTJUANA DESIGNS AND PROMOS INC.; (2) RAMGO INTERNATIONAL CORPORATION; (3) ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC.; (4) ILOILO FAITH ENTERPRISES & GEN. MANPOWER SERVICES INC.; (5) THREE N' ONE ENTERPRISES

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM, on Feb. 11, 2025, ARTJUANA DESIGNS AND PROMOS INC., RAMGO INTERNATIONAL CORPORATION, ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC., ILOILO FAITH ENTERPRISES & GEN. MANPOWER SERVICES INC. and THREE N' ONE ENTERPRISES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ARTJUANA DESIGNS AND PROMOS INC. is considered as the lowest offeror. However, the suppliers submitted Business Permit is expired. Therefore, considered as non-responsive.

WHEREAS, THREE N' ONE ENTERPRISES is considered as the second lowest offeror. However, upon post-qualification, wrong product was offered as per the suppliers response. Therefore, considered as non-responsive.

WHEREAS, RAMGO INTERNATIONAL CORPORATION is considered as the lowest responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by RAMGO INTERNATIONAL CORPORATION in the amount of Three Hundred Thousand Pesos Only (Php 300,000.00) is the lowest responsive quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Bagging Material to RAMGO INTERNATIONAL CORPORATION in the amount of Three Hundred Thousand Pesos Only (Php 300,000.00).
