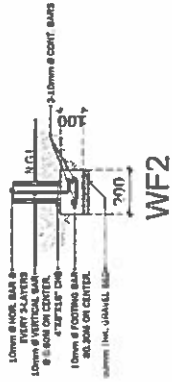

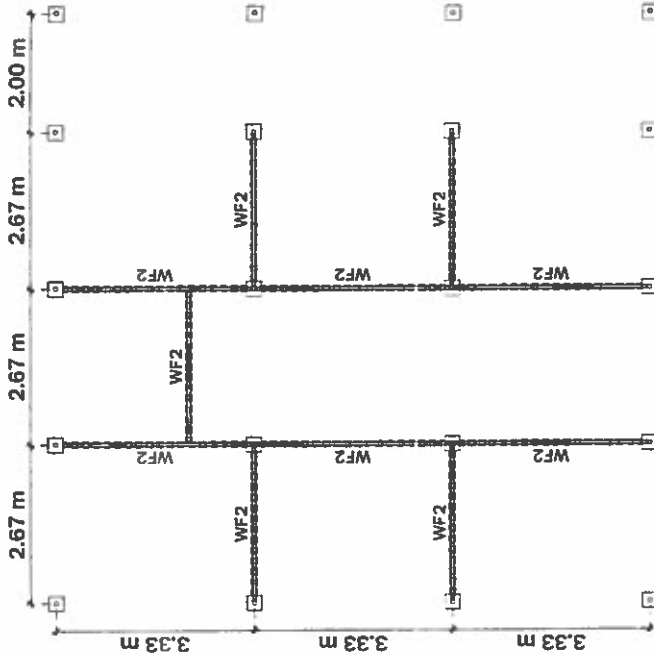
1 FOUNDATION PLAN
