

**BAC Resolution No. 0141, Series of 2025**

**Lease of Venue, Food and Accommodation during the conduct of FY 2025  
Provincial AFCs and Farmers Congress- Antique**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Lease of Venue, Food and Accommodation during the conduct of FY 2025 Provincial AFCs and Farmers Congress- Antique with an Approved Budget for the Contract (ABC) of One Hundred Eight Thousand Eight Hundred Pesos Only (Php 108,800.00).

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ANTIQUE FEDERATION OF COOPERATIVES** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
