**Lease of venue- With Food and Accommodation for the Conduct of  
Consultation on Organic Agriculture Stakeholders (Workshop on Organic Agriculture  
Livelihood Projects)**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Lease of venue- With Food and Accommodation for the Conduct of Consultation on Organic Agriculture Stakeholders (Workshop on Organic Agriculture Livelihood Projects) with an Approved Budget for the Contract (ABC) of Two Hundred Seventy-Three Thousand Seven Hundred Fifty Pesos Only (Php 273,750.00).

**WHEREAS**, on May 19, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **MO2 WESTOWN HOTEL**; (2) **EON CENTENNIAL RESORT HOTEL & WATERPARK**; (3) **ZURI HOTELS & SUITES**.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **MO2 WESTOWN HOTEL** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lease of venue- With Food and Accommodation for the Conduct of Consultation on Organic Agriculture Stakeholders (Workshop on Organic Agriculture Livelihood Projects) to **MO2 WESTOWN HOTEL** in the amount of Two Hundred Fifty-Two Thousand Five Hundred Pesos Only (Php 252,500.00).
