



## BAC Resolution No. 071, Series of 2025

### Procurement of Lease of Venue with Food and Accommodation

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Lease of Venue with Food and Accommodation with an Approved Budget for the Contract (ABC) of One Million Twenty-Nine Thousand Five Hundred Pesos Only (Php 1,029,500.00).

WHEREAS, on Apr. 24, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) NATURE'S VILLAGE RESORT; (2) MAY'S ORGANIC GARDEN RESTAURANT; (3) BACOLOD REAL ESTATE DEVELOPMENT CORP./ACACIA HOTEL BACOLOD; (4) GO HOTEL BACOLOD/ROBINSONS LAND CORP.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 PM. on Apr. 29, 2025, NATURE'S VILLAGE RESORT, MAY'S ORGANIC GARDEN RESTAURANT, BACOLOD REAL ESTATE DEVELOPMENT CORP./ACACIA HOTEL BACOLOD and GO HOTEL BACOLOD/ROBINSONS LAND CORP. submitted their quotations.
