

BAC Resolution No. 0111, Series of 2025

Lease of Venue with Food and Accommodation

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation with an Approved Budget for the Contract (ABC) of One Million Five Hundred Seventy Thousand Five Hundred Pesos Only (Php 1,570,500.00).

WHEREAS, on April 22, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) PUNTA VILLA RESORT INCORPORATED; (2) SM PRIME HOLDINGS, INC./PARK INN BY RADISSON ILOILO; (3) EON CENTENNIAL PLAZA HOTEL

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon, on April 28, 2025, PUNTA VILLA RESORT INCORPORATED, SM PRIME HOLDINGS, INC./PARK INN BY RADISSON ILOILO and EON CENTENNIAL PLAZA HOTEL submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, PUNTA VILLA RESORT INCORPORATED is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lease of Venue with Food and Accommodation to PUNTA VILLA RESORT INCORPORATED in the amount of One Million Five Hundred Thirty-Four Thousand Nine Hundred Seventy-Five Pesos Only (Php 1,534,975.00).
