Procurement of Food and Accommodation for the conduct of CY 2025 Mid-Year Assessment of DA AMIA Program on June 09-13, 2025 at Malay, Akla 1

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Food and Accommodation for the conduct of CY 2025 Mid-Year Assessment of DA AMIA Program on June 09-13, 2025 at Malay, Akla with an approved Budget for the Contract (ABC) of Eight Hundred Seventy-Nine Thousand Seven Hundred Fifty Pesos Only (Php 879,750.00).
