BAC Resolution No. 0327, Series of 2025

Procurement of Supply and Delivery of Shredder Machine

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Shredder Machine with an Approved Budget for the Contract (ABC) of Two Hundred Sixty Thousand Pesos Only (Php 260,000.00).

WHEREAS, on Feb. 5, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) SUKI TRADING CORPORATION; (2) AGRICOM VISAYAS INC.; (3) AGRIMACH CG CORPORATION; (4) ILOILO NEW AGRI-INDUSTRIAL MARKETING & GENERAL SERVICES, INC.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 12, 2025, SUKI TRADING CORPORATION, AGRICOM VISAYAS INC., AGRIMACH CG CORPORATION and ILOILO NEW AGRI-INDUSTRIAL MARKETING & GENERAL SERVICES, INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, AGRIMACH CG CORPORATION is considered as the lowest offeror. However, the supplier failed to comply the minimum requirements set by the agency. Therefore, considered as non-responsive.

WHEREAS, AGRICOM VISAYAS INC. is considered as the responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by AGRICOM VISAYAS INC. in the amount of One Hundred Ninety-Seven Thousand Pesos Only (Php 197,000.00) is the responsive quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant. WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Shredder Machine to AGRICOM VISAYAS INC. in the amount of One Hundred Ninety-Seven Thousand Pesos Only (Php 197,000.00).
