Procurement of 80 heads Darag Native Chicken

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of 80 heads Darag Native Chicken with an Approved Budget for the Contract (A3C) of Fifty-Two Thousand Five Hundred Ninety-Two Pesos Only (P52,592.00).

WHEREAS, on Feb. 24, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) NONG NOYS POULTRY & LIVESTOCK; (2) PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC.; (3) LA GRANJA DE MORENO; (4) JEZRA DARAG AGRI TRADING

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 P.M. on Mar. 3, 2025, NONG NOYS POULTRY & LIVESTOCK, PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC., LA GRANJA DE MORENO and JEZRA DARAG AGRI TRADING submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC. in the amount of Forty Seven Thousand Six Hundred Eighty Pesos Only (Php 47,680.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of 80 heads Darag Native Chicken to PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC. in the amount of Forty-Seven Thousand Six Hundred Eighty Pesos Only (Php 47,680.00).
