Provision of Food and Accommodation during the conduct of various activities of the Market Development Section in the Province of Antique

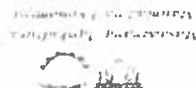
WHEREAS, the Department of Agriculture has a Purchase Request for the Provision of Food and Accommodation during the conduct of various activities of the Market Development Section in the Province of Antique with an Approved Budget for the Contract (ABC) of One Hundred Forty-Six Thousand One Hundred Ten Pesos Only (Php 146,110.00).

WHEREAS, on Feb. 25, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) PARVANA INN & SUITES; (2) ADELAIDE TOURIST AND TRAVELLERS INN, INC.; (3) KAMAPAT AGRICULTURE COOPERATIVE; (4) LA VENERANDA GUEST HOUSE

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM, on Mar. 4, 2025, PARVANA INN & SUITES, ADELAIDE TOURIST AND TRAVELLERS INN, INC., KAMAPAT AGRICULTURE COOPERATIVE and LA VENERANDA GUEST HOUSE submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, KAMAPAT AGRICULTURE COOPERATIVE is considered as the lowest offer and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
